

## **EVERGREEN HONOR AWARD- Rules and Regulations**

1. The purpose of the award shall be to pay the highest honor of Job's Daughters to adults in appreciation and recognition of their meritorious and unselfish efforts in assistance and support of the International Order of Job's Daughters.
2. The recipient shall be 25 years of age or older; a man or woman who has shown exceptional service to the order; with a minimum of five years during the past seven years, excluding the elected members of the Grand Guardian Council during their term of office and the work done therein.
3. All nominees must be living at the time of their nomination.
4. Application for conferral shall originate through and be approved by the Bethel Guardian Council on proper form provided by the Grand Guardian Council.
5. Applications shall be accompanied by at least four letters, giving good and sufficient reason(s) why they should be considered for this award.
6. Applications must be postmarked on or before **March 1, 2020**.
7. The chairman will notify each proposer by mail the Committee's decision regarding their nomination by April 15, 2020.
8. The cost of the approved award shall be paid by the recipients Bethel, family or anyone who wishes to contribute. Payment must be sent to the Grand Secretary of Washington **by May 1, 2020**. Checks should be made payable to Grand Guardian Council.
9. The knowledge of who has been nominated and who has been approved to receive the award **shall be kept strictly confidential** within the committee members and the Bethel Guardian Council.
10. The recipient shall receive the Washington Evergreen Award during Formal Opening at the Annual Session of the GGC. In the event that it is impossible for the recipient to attend, other arrangements for the presentation of the Washington Evergreen Award will be made by the Grand Guardian.
11. Each recipient will receive a certificate, provided by the Grand Guardian Council.

Please make copies of the recommendation form so one is available to each adult making a recommendation. **Give yourself plenty of time to complete a good and thorough packet for the committee to judge.**
