# 2023 Supreme Ritual Team(s) Agreement

## If I am selected as a member of the Washington Ritual Team I...

- Confirm that I'm an active member of Washington Job's Daughters and will not have attained majority by the competition day at Supreme Session.
- Will be present and on time to scheduled practices and events.
- Will come prepared with necessary supplies, clothing, and assigned ritual work to practices and events.
- Will heed the advice and guidance of my coaches.
- Will be a positive TEAM player.
- Will work hard, have fun, and have a good attitude.
- Understand that any Grand Chapter or Supreme Session costs for attending in person are the responsibility of the myself and my family.
- Understand that \*failure to follow the above code of conduct may result in being replaced with an alternate Daughter for the Grand Chapter performance or the Supreme Session competition, even if a portion of my Grand Chapter costs or Supreme Session costs have been paid for.

## As a parent of a member of either Washington Ritual Team, I...

- Will ensure that my child is on time to scheduled practices.
- Will ensure that my child is fed, rested, & ready to engage at scheduled activities.
- Understand that any Grand Chapter or Supreme Session costs for attending in person are the responsibility of the team members' family.
- Grant permission for my child to participate in fundraising to help offset the cost should fundraising be available.
- Understand that my child's travel arrangements, chaperone, and room accommodations are our responsibility to be arranged and booked by May 31<sup>st</sup> for the Grand Chapter performance and/or for Supreme Session.
- Understand that if I or my child violate the code of conduct, it may result in my child being replaced with an alternate for the Grand Chapter Performance or Supreme Session competition. (A member's removal from the team is at the sole discretion of the coaches. In the event of an issue, a warning will be given to the team member & parent will be notified.)

I grant permission for my Daughter to participate in this competition and be a part of the Grand Ritual Team (performs at Grand Chapter in Wenatchee, WA on 6/26/23) and/or Supreme Ritual Team (competes in person at Supreme Session in Middleton, WI 7/25/23). \*\*If allowing participation in only one of the above, please strike through the one that is not being permitted.
