

Evergreen Award 2023-2024

Rules and Regulations

The purpose of the award shall be made in recognition of outstanding service to Washington Job's Daughters.

The recipient shall be 25 years of age or older; a man or woman who has shown exceptional service to the order; with a minimum of five years during the past seven years, excluding the elected members of the Grand Guardian Council during their term of office and the work done therein.

All nominees must be living at the time of their nomination.

Members of a Bethel or a member of the GGC may recommend a nominee to the Executive members of a Bethel Guardian Council. Nominations shall be approved by any four members of the nominating Bethel Guardian Council.

At least four letters of recommendation from adults who know the nominee personally, other than relatives, shall be submitted with the nomination form. At least two of the letters shall be from current members of the Bethel Guardian Council (Executive or Associate) or from members of the Grand Guardian Council.

Applications must be postmarked on or before **March 1, 2024**

The chairman will notify each proposer by mail the Committee's decision regarding their nomination by April 15, 2024

The cost of the approved award may be paid by the proposer, the family or anyone who wishes to contribute. Payment must be sent to the Grand Secretary of Washington **by May 1, 2024** Checks should be made payable to Grand Guardian Council.

The knowledge of who has been nominated and who has been approved to receive the award **shall be kept strictly confidential** within the committee members and the Bethel Guardian Council.

The recipient shall receive the Washington Evergreen Award during Formal Opening at the Annual Session of the Grand Guardian Council. In the event that it is impossible for the recipient to attend, other arrangements for the presentation of the Washington Evergreen Award will be made by the Grand Guardian.

Each recipient will receive a certificate, provided by the Grand Guardian Council.

Please make copies of the recommendation form so one is available to each adult making a recommendation. **Give yourself plenty of time to complete a good and thorough packet for the committee to judge.**
