

## *Lily of The Valley 2023-2024*

### Rules & Regulations

The purpose of this honor is to pay special tribute to those Daughters who have continued to show active support to their Bethel and JDI of Washington by unselfish effort and commitment. To be considered for the honor, the nominee must meet the following criteria:

1. Be an active member of JDI
2. Be between the ages of sixteen (16) and twenty (20)
3. Shall have shown outstanding dedication to her home Bethel and JDI of WA for a minimum of two (2) years

A Daughter shall be nominated by the members of a Bethel Guardian Council without the knowledge of the nominee. Any Bethel Member may suggest a recipient to the Bethel Guardian. Recommendations by three (3) adults (other than relatives), two (2) of whom are Executive Bethel Council Members and who are knowledgeable of her qualifications to receive the honor shall be submitted with the nomination form. Nomination may be by the nominee's home Bethel and/or a Bethel to which she has contributed outstanding service to merit the nomination.

Do not wait until a Daughter is 20 to nominate her. If she is at least 16 and is doing great things, nominate her! If she is not selected the first time, she is still eligible to be nominated until she reaches the age of 20.

Be specific in your examples! Statements such as "she is the ideal Job's Daughter" or "she has served as HQ three (3) times" are too general. Keep in mind, also, that contributions should be "above and beyond" the norm. Helping with Proficiency and Ritual work within the Bethel, and helping younger Members and Bees are things that naturally happen in the course of being a Member of a Bethel. Please include what the nominee has done outside of her own Bethel. Has she supported other Bethels on a regular basis? Is she active at the State level? If so, how? Has she served on any committees? Is she well-known in the State for something?

The completed nomination packet must be submitted to the Committee Chairman by *March 1st, 2024*, or it will not be considered. The Committee Chairman shall notify the Bethel Guardian by April 15, 2024. If approved, will be given the cost of the medallion. Payment must be received by the Grand Secretary by May 1st, 2024. Please make checks payable to the Grand Guardian Council.

The ceremony will be performed by the Grand Bethel Officers, either at the Annual Meeting of the Grand Bethel, the Annual Meeting of the Grand Guardian Council, or at a special time approved by the Grand Guardian Council. On the page following these rules, you will find the nomination form and one (1) copy of the recommendation form. Please make copies of the recommendation form so that one is available and submitted by each adult making a recommendation. Please make sure completed nomination packet(s) are submitted to the Committee Chairman by March 1, 2024. No late nominations will be considered. The Committee will notify the proposer via e-mail when the packet is received. The Daughters are really excited about this award. Please remind them that they can nominate someone by talking to a Bethel Guardian.
